They conclude that there has been in Britain a move away from universally available benefits to means-tested income support. Despite this, the editors argue that Beveridge's important legacy has been the notion of a national minimum income: a safety net covering all. This idea has substantial present-day relevance as the countries of the European Community debate the issue of political and economic convergence.
